	Wenger is currently retired and formerly served as senior director of knowledge services strategy and innovation for Sun Microsystems. He is actively involved with the Rappahannock community as a member of the Rappahannock League for Environmental Protection board, Rappahannock Association for Arts and Community, and the Old Rag Master Naturalists group. Global Solutions Sustainability Challenge: An Authentic Virtual Exchange Experience – presentation by Melissa Stange, LFCC	LFCC students, Rachel Stange and Robert Wallace, led by LFCC professor of computer science Melissa Stange, presented on a collaborative project entitled <i>Global Solutions Sustainability Challenge:</i> An Authentic Virtual Exchange Experience.
professor of computer science (Information Item)	The Global Solutions Sustainability Challenge is a virtual exchange initiative that supports workforce development in the U.S. and Jordan. During the program, postsecondary students from the U.S. and Jordan team up to take on the global challenges facing the hospitality field. The program focuses on improving global citizenship, strengthening problem-solving skills, and developing enduring connections, while enhancing students' job skills. Global Solutions is supported by the Stevens Initiative, a program administered by the Aspen Institute and funded by the U.S. Department of State with additional funding by Bezos Family Foundation, and implemented by IREX.
	The project spans the Fall 2018 fall semester as a 12-week virtual exchange program through which LFCC students are partnering with students from Amman, Jordan to research and resolve a global sustainability issue. LFCC students spent 75 to 100 hours researching (and evaluating their research) sustainability and recycling programs in both the U.S. and Jordan. The students connected weekly via Facebook and virtual conference calls to collaborate during the research phase. The student teams then worked to develop a product, video, and detailed business plan to address a resolution. Participating with this project provides students with valuable hands-on experience working in the fields of hospitality, tourism, and global communications.
	LFCC students and the project have benefited from the support and consultation of local business and industry experts including Shentel Telecommunication, Nerangis Management Corporation and Luray Caverns.
	Next steps in the project's process include participating in the Global Solutions 2019-20 Challenge. Semifinalist teams/projects with the top- ranked solutions will travel to Washington, DC, to present their projects to a panel of expert judges from industry, academia, and the policy community.
	This was an information item and required no further action.

Board members reviewed the curricular change proposal (Attachment No. 1).</li> <li>The curriculum is designed to develop the knowledge base and skill required to prepare the student to function as an entry-level emergency medical technician. Successful performance in this program qualifies the student to take the National Registry's EMT exam.</li> <li>EMT curriculum was recently added to LFCC's existing emergency medical services (EMS) program. This action was to establish an EMT Academy option for dual enrollment students from the high schools in the LFCC service region. Adding the curriculum also expands financial aid options for students enrolled in the various EMS programs.</li> <li>On a motion made by Jeff Boppe, seconded by Pam McInnis, the emergency medical technician (EMT) career studies certificate was approved.</li> <li>(Attachment No. 1; 3 pages)</li> </ul>
Recommendation to approve Cyber Essentials Career Studies Certificate (Action Item)	<ul> <li>Karen Kellison presented to board members the cyber essentials career studies certificate for approval. Board members reviewed the curricular change proposal (Attachment No. 2).</li> <li>There is a growing number of technology students who are undecided as to which of LFCC's three technology programs to pursue while in high school or upon graduation from high school. The courses included in the proposed cyber essentials CSC are all existing courses being taught at LFCC. The courses were selected to allow a student to experience an exploration of each of the three technology pathways, while also completion of the cyber essentials CSC, having insight into each of the three technology pathways, students will be able to continue to pursue an AAS in cybersecurity, an AAS in information systems, or an AS in computer science.</li> <li>On a motion made by Mary Barton, seconded by Kathy Rosa, the cyber essentials career studies certificate was approved.</li> <li>(Attachment No. 2; 4 pages)</li> </ul>
Recommendation to approve Paramedic Certificate	Karen Kellison presented to board members the paramedic certificate for approval. Board members reviewed the curricular change proposal (Attachment No. 3).
(Action Item)	The curriculum is designed to develop the knowledge base and skill required to prepare the student to function as an entry-level

	paramedic. Successful performance in this program qualifies the student to take the National Registry's Paramedic exams.
	This certificate replaces the paramedic career studies certificate which will no longer meet the expectations of the organization of paramedic education by the relevant accrediting agency (Committee on Accreditation of EMS Programs/CoAEMSP). The VCCS EMS peer group developed a list of courses and sequencing that aligns with the guidelines set by CoAEMSP. The Virginia Office of EMS has also endorsed these changes. This curriculum change is consistent with other VCCS programs.
	On a motion made by Brad Hodgson, seconded by Jeff Boppe, the paramedic certificate was approved.

Recommendation to approve Discontinuance of Paramedic Career Studies Certificate	Karen Kellison presented to board members the discontinuance of paramedic career studies certificate for approval. Board members reviewed the curricular change proposal (Attachment No. 4).
(Action Item)	The associated courses for the paramedic career studies certificate (CSC) are being discontinued. As part of the redesign of the EMS curriculum by the VCCS EMS peer group, the decision was made to discontinue the paramedic CSC and create a paramedic certificate program. Students currently placed in the paramedic CSC will complete the curriculum in the Spring 2019 semester. These curricular changes are consistent with other VCCS programs.
	On a motion made by Mary Barton, seconded by Brad Hodgson, the discontinuance of paramedic career studies certificate was approved.

Recommendation to approve Discontinuance of Administration of Justice Career Studies Certificate (Action Item)	Karen Kellison presented to board members the discontinuance of administration of justice career studies certificate for approval. Board members reviewed the curricular change proposal (Attachment No. 5). While the degree specialization is healthy and growing, only 3 students have enrolled in the administration of justice career studies certificate program in the past 4 academic years. There is no benefit to the student or the College to maintain the CSC as it is not a stackable
	credential in a practical sense towards completion of the AAS degree in administration of justice.
	On a motion made by Mike Lake, seconded by Rich Galecki, the discontinuance of administration of justice career studies certificate was approved.

Recommendation to approve Discontinuance of Emergency Medical Technician Intermediate (EMT-I) Career Studies Certificate (Action Item)	<ul> <li>Karen Kellison presented to board members the discontinuance of emergency medical technician intermediate (EMT-I) career studies certificate for approval. Board members reviewed the curricular change proposal (Attachment No. 6).</li> <li>The National Registry of EMTs will no longer offer certification testing for the EMT Intermediate certification level after December 31, 2019. As a result, the Virginia Office of EMS will no longer sanction EMT-I certification courses. The VCCS EMS peer group has revised the EMS curriculum, and the associated courses for this certification will no longer be available.</li> <li>Students currently enrolled in the EMT-I CSC will complete their courses at the conclusion of the Spring 2019 semester. Based on previous graduate performance, there will be sufficient time for them to complete the certification testing process before the December 31, 2019 deadline.</li> <li>A crosswalk has been developed for graduates of the EMT-I CSC and current EMT-I providers, to enter the new EMS curriculum (paramedic CSC and AAS degree).</li> <li>On a motion made by Kathy Rosa, seconded by Mary Barton, the discontinuance of emergency medical technician intermediate (EMT-I) career studies certificate was approved.</li> <li>(Attachment No. 6; 3 pages)</li> </ul>
Nomination process and criteria for recipients of the 2019 College Board Medallion of Recognition (Information Item)	Board Chair Bill Daniel shared with board members the criteria for recipients of the College Board Medallion of Recognition. Nominees must be national, state or local leaders of business, education or government (elected officials currently holding office are not eligible for nomination); persons from the College's service area who have made significant contributions to the College; or retiring LFCC employees in good standing employed by the College for at least 10 years who made significant contributions during their employment. A listing of all previous medallion recipients to date was provided to board members. Board members should submit their nominations to the President's Office by January 21, 2019 so that nominations can be reviewed and presented for board approval at the February 2019 College Board meeting. #### **REPORT OF THE EDUCATIONAL FOUNDATION BOARD REPRESENTATIVE**

Mary Barton, LFCC Educational Foundation Board representative, reported on the following:

In early November 2018, the Fauquier County Board of Supervisors met and proposed a land donation of 50 acres adjacent to the LFCC Fauquier campus to the LFCC Educational Foundation. There are caveats to the gift proposal that need to be discussed among the College, the Foundation and Fauquier County prior to any agreement and receipt of the donation.

The financial status of the LFCC Educational Foundation is in great standing. The Foundation Board reviewed the LFCC Foundation's portfolio with representatives of Fauquier Bank in attendance at its November 29<sup>th</sup> meeting, with current investments at approximately \$7.3 million.

	REPORTS OF THE COLLEGE
Financial and Administrative Services	Chris Boies reported on the following:
	The LFCC Foundation authorized staff to issue an RFP to hire a contractor for the Luray-Page County Center building. The financial plan for this project was reviewed with the Foundation Board. There is a small deficit that needs to be overcome with either increased fundraising or reduction in the building's scope. The College will work

	with the hired contractor on the building design and value engineering to get the project to budget.
	The College is awaiting the release of the state budget from the Governor's office, which should be received in three weeks.
	Technology is a large piece of operations at LFCC. The College services on its campuses and locations approximately 3,200 computer stations, 450 phones, and 250 printers. LFCC's information technology unit responds to approximately 2,500 help desk requests per year. LFCC's chief information officer (CIO), Richie Crim, was named by Center for Digital Education as a 'Top Thirty Technologists, Transformers, and Trailblazers'. The Center for Digital Education has also ranked LFCC number one in in its enrollment size category in the nation for the use of digital technology in education.
Workforce Solutions and	Jeanian Clark reported on the following:
Continuing Education	The Workforce Solutions Winter-Spring 2019 course catalog was distributed to board members. Computers and technology certifications and credential course offerings were highlighted including the CompTIA certifications. WSCE is now a CompTIA certified academy.
	WSCE is also currently working on the Amazon Web Services certification, which is another short-term credential that will support Amazon data centers.
Fauquier	Chris Coutts reported on the following:
	LFCC has hired a fulltime faculty member in cybersecurity, Alvin Brewer, who is primarily based at the Vint Hill Site. The cybersecurity lab at Vint Hill is being expanded with funding from a recent grant. Condensed programming in cybersecurity is now being offered at the Vint Hill Site and has proven to be popular with students per enrollment data.
	LFCC is part of a GoVirginia grant, which is a state-wide economic development grant with funding partnership with Germanna and Piedmont community colleges. The focus of this grant is on cybersecurity and economic development. LFCC, Germanna and Piedmont are working with business and industry to coordinate their cybersecurity training programs.
	The growth of LFCC programming in the Rappahannock area continues.
	LFCC was awarded an \$84,531 grant from the VCCS Rural Virginia Horseshoe Initiative (RVHI) to create a student success program for underrepresented students. LFCC received matching funds from the

	PATH Foundation. LFCC's Fauquier campus does not have programs specifically for students who are considered at risk, including under-represented, low-income students.
	The <i>Paths to Success</i> project addresses gaps in support to under- represented students in the Fauquier community by hiring a student success coach who will work with the school system to identify students, create a bridge program for these students, and provide wrap-around support for students who are first-generation, low- income, and face multiple barriers to education attainment.
	The success coach serves the Fauquier and Rappahannock communities. This project will provide:
	<ul> <li>a single point of contact for all student supports through the success coach position;</li> <li>embedded tutoring in required English, math, and</li> </ul>
	<ul> <li>developmental courses;</li> </ul>
	<ul> <li>additional individual tutoring;</li> <li>recourses such as textbooks and source supplies, assistance</li> </ul>
	<ul> <li>resources such as textbooks and course supplies, assistance with access to community-based services, incentives for student achievement;</li> </ul>
	<ul> <li>resources for coach to meet with students and provide incentives;</li> </ul>
	<ul> <li>incentives;</li> <li>implementation of a financial education and literacy program;</li> <li>implementation of an employability skills program (including resume assistance, application review, interview skills, and customer service skills); and</li> </ul>
	<ul> <li>implementation of a summer bridge to college program for recent high school graduates.</li> </ul>
Academic and Student Affairs	Karen Kellison reported on the following:
	As part of LFCC's accreditation with SACSCOC, the College has a five- year quality enhancement plan campaign that focuses on information literacy. Each semester, LFCC provides mini grants to full-time or adjunct faculty or staff who requests funds to support an information literacy initiative. One of the Spring 2019 mini grants has been awarded to the College's instructional design team to facilitate training and feedback sessions for faculty, staff and students on the usage of LFCC's new learning management system (Canvas). Another mini grant was awarded to an LFCC geology adjunct faculty to incorporate more scholarly research into the course curriculum.
	Faculty are working diligently on creating more specific pathways for students from their program coursework at LFCC to four year institutions. LFCC has developed pathway agreements with Shepherd University in biology, criminal justice, psychology and human services. These pathway agreements are in addition to the program areas of chemistry and outdoor recreation, which were signed previously.

	Pathway agreements currently in process are in education and communications. Shepherd University also offers LFCC transfer students a 25 percent tuition discount.
Institutional Advancement	Liv Heggoy reported on the following:
	A copy of LFCC's sponsored content entitled 'College Connection' that is being published in four local newspapers throughout LFCC's service region was shared with board members. The article highlights the 2018-19 Ross Fellowship recipient Ashley Pullman; an LFCC associate of science graduate Meredith Dhillon now employed as a physician assistant specializing in mental health; LFCC new student club aimed at creating a nurturing, socially-supportive environment for neuro-diverse students; and a recent LFCC graduate, Jonathan Branson, who earned an associate of science degree in computer science in May 2017 and is now employed by IBM.
	Board chair Bill Daniel was thanked for hosting a successful and well- attended welcome reception in Clarke County for LFCC president Kim Blosser in early November.
	It is the Foundation's goal to achieve one hundred percent board member giving from both the Educational Foundation and local College boards. Board members were thanked for the many ways they have supported the Foundation and the College.
	President Kim Blosser's inauguration will be held on April 26, 2019. An inauguration is not only a formal recognition of the new college president, but also an opportunity to celebrate LFCC and the institution's impact in the community. An inauguration typically occurs 12 to 16 months into a presidency. It is a wonderful occasion to honor the College's past, highlight its success, and share a vision for the future.
	Delegates from colleges and universities across the Commonwealth will be attending, as will local community leaders and colleagues from the VCCS including Chancellor DuBois.
President	Kim Blosser reported on the following:
	With the announcement of Amazon's selection of the Northern Virginia area to locate one of its second headquarters, much discussion is being held on the impact to higher education. There is funding for community colleges and four year institutions to begin working on clear pathways and articulation agreements in the areas of cybersecurity and computer science. It will require a united effort to educate and skill the needed workforce. LFCC does have an advantage geographically to assist with the pipeline of skilled workers for the new

headquarters, as well as for backfilling vacancies at other employers whose employees take positions at the new headquarters.
Governor Ralph Northam announced a collaborative effort to transform workforce programs offered through the Virginia Community College System (VCCS). Governor Northam has allocated \$5 million of federal workforce discretionary funds to support the redesign of Virginia's community college system. This is a new initiative that rethinks the way community colleges in Virginia serve students, businesses, and the community. It is called the G3 (Get Skilled - Get a Job – Give Back). Each college will compete for funds used to rethink how they will do business and support students as well as current and future companies. Each college will receive a minimum of \$100,000 and a maximum of \$500,000. At the heart of this initiative is a plan to realign workforce credentialing and degrees toward the in-demand jobs of today.
LFCC members will be attending the SACSCOC annual meeting next week, at which a vote will be held on the mixing of dual enrollment and AP students in one classroom. SACSCOC received an enormous amount of feedback in support of maintaining the current structure. It is anticipated that the recommendation regarding changing the existing standard will be rescinded.

1. Summary of proposed curricular change (please include a copy of the current and revised catalog to show curricular changes for all programs this proposal affects):

This proposal seeks to establish a Career Studies Certificate (CSC) for Emergency Medical Technician.

### Career Studies Certificate: Emergency Medical Technician

**AREA:** Emergency Medical Services **CSC:** EMT **LENGTH:** One semester

Lord Fairfax Community College

**PURPOSE:** The curriculum is designed to develop the knowledge base and skill required to prepare the student to function as an "entry-level" Emergency Medical Technician (EMT). Successful performance in this program qualifies the student to take the National Registry's EMT exam. Purchase of clinical scheduling and skills tracking and EMS testing account through designated vendor.

OCCUPATIONAL OBJECTIVES: To operate as an "entry-level" EMT

#### ADMISSION REQUIREMENTS:

- 1. Attend a mandatory EMS orientation session with instructor
- 2. Be a minimum of 16 years of age at the beginning date of the EMT course. If you are less than 18 years of age, you must provide your instructor with a completed parental permission form with the signature of a parent or guardian verifying approval for enrollment in the course.
- 3. Have no physical or mental impairment that would render you unable to perform all practical skills required at the EMT level.
- 4. Not have been convicted of or found guilty of any crime, offense or regulatory violation, or participated in any other prohibited conduct identified in state EMS regulation 12VAC5-31-910.
- 5. To complete the Clinical and Field Internship portions of the program, submit results of a physical exam completed within the last 12 months as proof of immunizations or resistance to measles, mumps, rubella, Tdap, polio, Hepatitis B Vaccination, and TB

Skin test within the last12 months. If PPD is positive, submit results of chest x-ray showing negative for active TB

- 6. LFCC placement tests and completion of any developmental work that may be identified by the placement test. Must show competency in MTE 1-2 and eligible for ENG 111 to satisfy requirements without taking remediation.
- 7. Residents from outside the Lord Fairfax Community Service Area are admitted only after all applicants who reside in the College service area have been considered.
- 8. Completion of criminal background search, fingerprinting, and drug screen as required and to the satisfaction of affiliating clinical agencies.

**ACCREDITATION:** The EMS program at LFCC is fully accredited by the Virginia Office of EMS and the Commission on Accreditation of Allied Health Education Programs.

2. Rationale for proposed change:

The EMS Program at LFCC recently added the EMT curriculum. This action was to establish an EMT Academy option for dual-enrollment students from the high schools in the LFCC service region. Adding the curriculum also expands financial aid options for students enrolled in the various EMS programs.

3. Impact of the proposed change on the following:

- A. Transferability and/or employability: The CSC is a non-transferable certificate
- B. Personnel / Instructional load: This revision does not affect instructional load
- C. Scheduling of classes: There are no scheduling changes
- D. Overall credit hours in the program(s): The credit load for the CSC is 10
- E. Instructional resources: Additional resources were obtained through Perkins grants and other resources to ensure appropriate equipment is on-hand
- F. Facilities: Proposal does not affect facilities
- G. National, state, or regional associations: This proposal does not affect these entities
- H. SACS accreditation / substantive change: This proposal will not affect SACS accreditation
- I. Any students currently enrolled in the program (if applicable): The first group of dualenrolled students (EMT Academy) would be eligible for this CSC.

4. Input from curriculum advisory committee(s) (and other persons "in the field"): The EMS CAC was consulted regarding this proposal and recognizes the need for it.

   Add a Cyber Essentials Career Studies Certificate (CSC) for undecided technology students.
   Simultaneous to this new program proposal is a proposal to discontinue the current Information Technology Foundations CSC (details in separate proposal).
- 2. Rationale for proposed change:
  - There is a growing number of technology students who are undecided as to which of LFCC's three technology programs they would like to pursue while in High School or upon graduation. The courses included in the proposed Cyber Essentials CSC are all existing courses being taught at LFCC. The courses were selected to allow a student to experience an exploration of each of the three technology pathways, while also completing some general education credits.
    - Computer Science, Cybersecurity, and IST degree programs have SDV101 and ENG111 as core degree requirements. ITN100 is a required core class of Cybersecurity and IST. ITN100 is an optional elective class for Computer Science.
    - ITP 100 is part of the IST and Cybersecurity programs, while not part of the Computer Science Specialization the course would give a student a foundation to build upon in CSC 200.
    - ITN 260 is part of the IST as an elective in the degree and required for the IST Cybersecurity CSC. In the Cybersecurity degree, ITN 260 is a required core class. ITN 260 is not part of the Computer Science Specialization, but the course will provide the students an exposure to the importance of cybersecurity when working in Computer Science in areas such as secure programming.
    - CSC 110 is part of the Computer Science Specialization and may be approved as an elective in the IST degree, depending on the concentration track, such as Software Development or Web Design. CSC 110 will provide a programming foundation for ITP 270 course within the Cybersecurity program.
    - ITE 120 is part of the IST curriculum; while not part of the Cybersecurity or Computer Science program, it will provide students in both programs an excellent overview of technology careers.

• Several of the included courses are also available through dual enrollment, which would allow high school students to start exploring the differences between the three programs before high school graduation.

By the time a student completes these courses, they should be able to decide which of the three technology degree pathways they would like to pursue. In addition to completion of the Cyber Essentials CSC, having an insight into each of the three technology pathways, students will be able to continue to pursue an AAS in Cybersecurity or an AAS in Information Systems or an AS in Computer Science.

Several have switched between the programs so this career studies certificate will allow them to earn the Cyber Essentials credential. To have a CSC in Cyber Essentials will assist students in technology to select the best degree program earlier in their education plan and reduce or eliminate the number of credits found to be not applicable to any program. The Cyber Essentials CSC would also provide students a basic level of technology knowledge, which may help them obtain employment working as a Help Desk or Tech Support person.

4. Input from curriculum advisory committee(s) (and other persons "in the field"):

The benefit to having a Career Studies Certificate in Cyber Essentials has been discussed with Dean Byard, VP Kellison, and the President along with other LFCC technology faculty. The IST Curriculum Advisory Committee is in favor of this proposed new CSC. The Computer Science Specialization does not have a CAC, because it is a transfer program. This CSC creation is being proposed with feedback from LFCC students currently enrolled in multiple technology program. Jonathon Bullock (IST & Computer Science), Edwin Trujillo (Computer Science & Cybersecurity), Renato Scudere (Cybersecurity & Computer Science) and those who have switched programs and lost credits such as Michael Diaz (Cybersecurity to IST).

ODU, JMU, GMU, and GWU were contacted about the issue and the Cyber Essential supported such a CSC, because they are three distinct programs of study at their institutions and having students understand the differences prior to starting the transfer process will only help students enroll and be more successful in their institutions. GMU has a BS and BAS in Computer Science. Having the IST and Computer Science expose in the CSC my help the student decide which Computer Science degree to pursue sooner or it may direct them to GMUs BAS in Cybersecurity. It is critical that students know which pathway they want to pursue before transferring because there are not a lot of elective courses they could transfer extra credits into ODU Computer Science, IT, Cybersecurity. GWU has a five-year program that students may transfer to and earn a degree in Computer Science and Cybersecurity, such a Cyber Essential CSC would give them a head start for such a program

because they would have been exposed to both areas before transfer. All of the courses in the proposed CSC are currently being offered at LFCC.
