	A quorum of votes to approve the recommendation was received.  The first step in this process is to obtain local College Board approval to move forward with the use of workforce funds to support the expansion of the Smith Building adding facility space for three newly constructed labs. The project is expected to be less than 5,000 square feet of additional space and cost less than \$3,000,000 to construct, thereby not needing DEB (Department of Engineering and Buildings) approval, but only local College Board and the State Board for Community College's approval. Approval to Lease the Luray-Page County Center from the LFCC Foundation (Information Item)	The recommendation to lease the Luray-Page County Center from the LFCC Educational Foundation was submitted to board members for review and approval via electronic mail on August 8, 2019. 	New Business
LFCC Institutional Priorities AY 2019-20 (Information Item)	Kim Blosser reviewed LFCC's institutional priorities for the 2019-20 academic year with board members (Attachment No. 3). Institutional priorities supporting enrollment stabilization, administrative strength, and leadership and innovation were determined through a process including faculty, staff and administration. Once determined by the College, the priorities were submitted to the VCCS Chancellor for review and approval. Near the conclusion of the 2019-20 academic year, the president will provide the College Board with an institutional priorities progress report as part of the president's annual evaluation by the board.  This was an information item and required no further action.  (Attachment No. 3; 4 pages)
Recommendation to approve Name Change of Cyber Essentials Career Studies Certificate to Technology Essentials Career Studies Certificate (Action Item)	Karen Kellison recommended to board members the name change of cyber essentials career studies certificate (CSC) to technology essentials career studies certificate for approval. Board members reviewed the curricular change proposal (Attachment No. 4).  The term 'technology' rather than 'cyber' is more reflective of the overall purpose and content of this CSC. The courses in this program belong to multiple technology-related programs including computer science, cybersecurity, and information systems technology.

	On a motion made by Brad Hodgson, seconded by Mary Barton, the recommendation was unanimously approved.

Recommendation to approve Applied Computer Science Career Studies Certificate	Karen Kellison recommended to board members the applied computer science career studies certificate (CSC) for approval. Board members reviewed the curricular change proposal (Attachment No. 5).	
(Action Item)	Due to the limited number of K-12 educators within our service region currently with master's degrees in computer science of 18 graduate credits in computer science to meet SACSCOC accreditation requirements, school systems are unable to provide computer science dual enrollment opportunities. The proposed CSC would allow the K-12 schools to provide a computer science foundation with existing IT courses.	
	In addition, adult learners who want to enter or switch to the computer science field, who do not have prior technology experience, often struggle with the theory concepts within computer science. This certificate would offer them an entry level starting point.	
	On a motion made by Mary Barton, seconded by Kathy Rosa, the applied computer science career studies certificate was unanimously approved.

Recommendation to approve Cybersecurity and Networking Foundations Career Studies Certificate	Karen Kellison recommended to board members the cybersecurity and networking foundations career studies certificate (CSC) for approval. Board members reviewed the curricular change proposal (Attachment No. 6).	
(Action Item)	The proposed CSC is part of the VCCS-sponsored G3 (Get Skills, Get a Job, Give Back) Initiative that is the first of three levels. Level 1 is the proposed CSC which has been standardized within parameters across the VCCS. The G3 initiative focuses on training Virginians for high-demand jobs that meet employer demand in our community. Pathways include IT, cybersecurity and other high-demand areas. The rationale is that students learn skills first with multiple levels of training that will lead to careers.	
	On a motion made by Mary Barton, seconded by Craig Lancto, the cybersecurity and networking foundations career studies certificate was unanimously approved.

### Recommendation to approve Discontinuance of Information Technology Foundations Career Studies Certificate

(Action Item)

Karen Kellison recommended to board members the discontinuance of information technology foundations career studies certificate (CSC) for approval. Board members reviewed the curricular change proposal (Attachment No. 7).

A new CSC in cyber essentials was approved in 2018 that provides a broader set of exploratory courses for undecided students to help determine which specific area of technology they wish to pursue. The presence of two, introductory, exploratory CSC programs is redundant and potentially confusing for new students.

In addition, as a feeder program, the information technology foundations CSC does not provide the breadth of exploratory courses for students to determine which technology pathway (information systems technology, cybersecurity, computer science, etc.) they should follow.

On a motion made by Mary Barton, seconded by Craig Lancto, the discontinuance of information technology foundations career studies certificate was unanimously approved.

# Recommendation to approve FY 2020-21 College Board Budget

(Action Item)

Jeanian Clark, interim vice president of financial and administrative services, recommended to board members the FY 2020-21 College Board budget of \$364,000 for approval. Board members reviewed the proposed budget (Attachment No. 8).

The College's localities, which provide funding for this budget, begin requesting the College's budget proposals for the next fiscal year in the fall of the current fiscal year. The College Board budget consists of various funds spent by different departments within the College, as well as funding for College Board scholarships rewarded to students in each of the localities.

The FY2019-20 College Board budget proposes to maintain the same funding request as the previous year of \$364,000.

### REPORT OF THE EDUCATIONAL FOUNDATION BOARD REPRESENTATIVE

Michael Lake, newly appointed LFCC Educational Foundation Board representative, deferred to Liv Heggoy who reported on the following:

The October Educational Foundation Board meeting focused on the many building projects the Foundation is either overseeing or indirectly involved with due to reasons such as site work funding for Hazel Hall. The board also discussed how the Foundation can assist with securing rental space at Vint Hill for the next couple of years due to the delay in construction of Hazel Hall. Vint Hill currently houses the Fauquier area heavy equipment operator program as well as the surgical technology and electrical program. The Foundation has received a \$130,000 grant that can be used to fund the Vint Hill lease payment.

The Foundation has recently received the site work budget for construction of the new Luray-Page County Center. It is anticipated to receive final architectural drawings mid-October. The final drawings enable the construction management company to solicit bids to determine guaranteed maximum price, which is needed to close on the loan for the project. The Foundation will move forward with selecting a lender.

The County of Fauquier will be transferring 50 acres of property adjacent to the Fauquier campus to the Foundation. The Foundation and Fauquier County have come to an agreement on the provisions of accepting the land donation. The Foundation will explore a feasibility and fundraising capacity study to determine path towards construction of a Foundation owned facility on the Fauquier campus within eight years of date of land transfer.

### REPORTS OF THE COLLEGE

### **President**

Kim Blosser reported on the following:

In March 2019, the final price on the construction of Hazel Hall was determined. That price was approximately \$20 million, but the state appropriation LFCC received was only \$15 million resulting in a \$5 million shortfall. Since that time, LFCC leadership worked with the VCCS to submit a request to the State for additional funding. Unfortunately, the Department of Planning and Budget denied the request, which will require the funding request to go back through the State Budget process during this upcoming legislative session.

The new funding request will also include renovation of existing lab space in Wolk Hall. The VCCS feels confident the additional funding will be included in the budget, and LFCC leadership will work with our local legislators to ensure it remains part of the final budget bill. Assuming the request is approved as the VCCS anticipates, funding will be received effective July 1, 2020, to move forward with the construction. The president has been meeting with many stakeholders in the community communicating details of the project.

A nation-wide search for the position of vice president of financial and administrative services is in process. The search committee will begin reviewing applicants in the coming week and anticipates holding interviews in November with a new hire beginning January 2020.

	Jeanian Clark has graciously and very successfully served as interim throughout the past year.
	The president has sent forward a one-time appropriation request in the amount of \$475,000 to Delegate Todd Gilbert and Senator Mark Obenshain to fund interior furnishings of the new Luray-Page County Center. Both Gilbert and Obenshain have agreed to support this request through the upcoming budget process pending reelection.
Financial and Administrative Services	Jeanian Clark, interim vice president of financial and administrative services (FAS), reported on the following:
	The FAS unit is very intensely focused on facilities and building projects including Hazel Hall, the new Luray-Page County Center, the extension of the Smith Building at the Middletown campus, and scheduling major plumbing repair at the Fauquier campus.
	A construction project inspector was hired in September, and a director of facilities should be selected and brought on board in November. These positions will be pivotal support roles during the next few years of capital projects and major renovations.
Fauquier Campus	Chris Coutts, Fauquier campus provost, reported on the following:
	The Fauquier campus team is maintaining focus on servicing students in the midst of several facility projects including extensive plumbing maintenance and repair, a roof replacement project, and major VDOT roadway construction at the entrance of the campus.
	Enrollment at the Fauquier campus continues to grow and recently surpassed the goal of 2,000 and is currently at 2,005. New student enrollment is up 9 percent.
Institutional Advancement	Liv Heggoy, associate vice president of institutional advancement and executive director of the LFCC Educational Foundation reported on the following:
	The Foundation is currently interviewing candidates for the position of a fulltime development officer to be based at the Fauquier campus and focused on the counties of Fauquier and Rappahannock.
	The office of institutional advancement is preparing recognition and celebration of LFCC's upcoming 50 <sup>th</sup> anniversary for the calendar year of 2020, as the LFCC Middletown campus first opened its doors in 1970.
	The institutional advancement unit will soon be searching for a director of grants.

	The Foundation recently received donations to support dual enrollment scholarships for students (\$150 per student to cover one dual enrollment course) in Warren, Frederick and Clarke counties. This type of giving is a great example of how a relatively modest donation can have great impact assisting multiple students.	
Academic and Student Affairs	Karen Kellison, vice president of academic and student affairs, reported on the following:	
	The LFCC computer science department has sponsored and coordinated a series of technology talks with industry experts (Tech Bytes) that will be held throughout the next several months. The Tech Bytes series has attracted an impressive array of speakers, including former Secretary of the Navy Richard Danzig, co-founder of the Berryville Institute of Machine Learning Gary McGraw and other cyber experts who will examine the future of technology and computer science. The series is being funded by a grant LFCC received as part of the 2019 NCWIT Academic Alliance Seed Fund, which is powered by the National Center for Women and Information Technology with support from Microsoft Research. The series are open to the public.  A search for the position of dean of health professions is currently in process with final candidates participating in on-campus interviews throughout the coming weeks.	
	LFCC is participating in a partnership with JMU to create a process for communication among K-12, two-year and four-year institutions, economic development leaders and industry in the early stages of program development. This partnership is being funded by a SCHEV grant.	
	LFCC recently signed a 2+2 chemistry agreement with Radford University's Artis College of Science and Technology (two years at LFCC to earn an associate of science degree with a chemistry specialization, and two years at Radford University for a bachelor of science degree). The agreement provides students interested in pursuing a bachelor's degree in chemistry with a seamless transfer option with Radford University. It will allow students graduating from LFCC to pursue five different chemistry concentrations at Radford, including biochemistry, forensic chemistry and advanced professional chemist. LFCC previously established several 2+2 transfer agreements with Shepherd University that also offer a tuition discount for LFCC students.	
Workforce Solutions and Continuing Education	Bill Pence, coordinator of business and industry training, reported on the following:	
	The WSCE Fall 19 health care programs have launched at capacity with waiting lists of future enrollment. The HEO program recently brought to the Middletown campus has also launched at capacity.	

The HEO Fast-Track career training program has also expanded as an online hybrid course in partnership with other community colleges throughout the state. Instruction is received online, while skill testing is held at several simulation sites located throughout the region.

WSCE is seeing success with the guarantee to interview program model, in which credentialed graduates of programs are guaranteed a job interview with a local partner employer. Guarantee-job-interview programs include HEO, IT, manufacturing technician, and certified personal trainer.

WSCE's CompTia prep and certification programs are also performing well with 35 students completing the fundamentals course that leads into the A+ program. This program also offers a guaranteed interview upon successful completion.

Initiating Administrator's Recommendation (If funding is involved, please indicate appropriate budget line item number and title.):

LFCC Workforce Solutions has been operating Trades Programs in multiple off-site locations over the past five years. There has been no available lab space at either the Middletown or Fauquier campuses to offer these programs. Presently, there are four levels of Electrical, Plumbing, and HVAC apprenticeship programs offered in both the Middletown and Fauquier service areas running twice per year. This totals 48 classes serving hundreds of students each year.

The Middletown trades programs have been running at two partner locations in the community. These partners are Goodwill Industries and Winchester City Public Schools. The facilities are adequate, but not desirable. Goodwill has provided us with an empty warehouse, which has security and infrastructure concerns. Winchester City Public Schools (WCPS) has allowed us to use a former elementary school that is 50 plus years old, which WCPS is presently scheduled to renovate over the next two years.

Recently, both Goodwill Industries and WCPS have informed us of changes to their plans, which has forced the college to relocate the trades programs from both of their facilities effective July 2019. Although a temporary plan has been identified, it is not a desirable long-term solution.

In 2014, the VCCS set up a non-verting cash account for Workforce Units to keep their accumulated surplus tuition funds to be reinvested locally in development and growth of future Workforce programs in agreement with the college mission, vision, and strategic goals. Over the past four years, LFCC's Workforce Solutions team has been strategically and aggressively generating additional program tuition revenues, above their direct and indirect costs, to invest in future facilities for their programs. This non-verting cash fund is what would be used to support this request.

The College has identified the current Smith Building at the Middletown campus as the ideal location to add additional laboratory space for these workforce programs. To help support our case with the State, and to determine the amount of space needed for an expansion, last year the college hired an architect to do preliminary designs.

In July 2019, the college initiated a request with the VCCS to use workforce funds to support building an addition onto the existing Smith Building. The VCCS is supportive of this request and is working with the college on the steps needed to move this request forward.

The first step in this process is to obtain local College Board approval to move forward with the use of workforce funds to support the expansion of the Smith Building adding facility space for three newly constructed labs. The project is expected to be less than 5,000 square feet of additional space and cost less than \$3,000,000 to construct, thereby not needing DEB (Department of Engineering and Buildings) approval, but only local College Board and the State Board for Community College's approval.

This project will follow state capital funding procedures and will be managed by the VCCS. We will continue to provide updates on the status of the request and overall project at future College Board meetings.

Agenda Item Title: Approval to Lease the Luray-Page County Center from the LFCC

Initiating Administrator's Recommendation (If funding is involved, please indicate appropriate budget line item number and title):

The College leases 7,500 square feet of space at 334 N. Hawksbill St. in Luray to operate the Luray-Page County Center. The annual lease payment is \$55,000, and the existing lease ends in July 2020. The new Luray-Page County Center will be owned by the LFCC Foundation, as is the Student Union at the Middletown Campus.

We are planning for the new Luray-Page County Center to open in Fall 2020.

It is advised that the local board provide its approval for the College to lease the Luray-Page County Center from the LFCC Foundation. The VCCS must approve the lease agreement. This was the process followed for the Student Union lease.

The College has budgeted \$110,000 annually for the new lease, to begin in July 2020. The proposed initial lease term will be ten years with renewable options in five-year increments.

The LFCC Foundation received 8.3 acres of donated property in the Luray Landing development behind Wal-Mart in Luray and has recently completed a capital campaign to support the project.

In addition to more space (11,000 square feet), the new building will include science and trades labs and a board room, which we do not have at the current center.

On February 1, 2018, the College and Foundation boards approved naming the building Russell A. and Rodney A. Jenkins Hall. The architect shared the preliminary renderings of the new center with the College Board on October 4, 2018. The community gathered for a ceremonial groundbreaking at the site on May 16, 2019.

The Foundation's lender will require a copy of the lease agreement for the construction loan closing.

- Due to the limited number of K-12 educators within our service region currently with Masters degrees in Computer Science or 18 graduate credits in Computer Science to meet SACSCOC accreditation requirements, school systems are unable to provide computer science dual-enrollment opportunities. The proposed Applied Computer Science Career Studies Certificate would allow the K-12 schools to provide a CS foundation with existing IT course.
- 2. Adult learnings who want to enter or switch to the CS field, who do not have prior technology experience often struggle with the theory concepts within computer science. This certificate would offer them an entry (L1) starting point.
